3.	Declarations of Interest	None	
4.	Overview of key policy changes	<p>Cllr Keith R Mitchell introduced the item and outlined two significant savings proposals that the county council has announced around Libraries and an early intervention service bringing together a range of services for children, young people and families.</p> <p>Bishop Colin Fletcher gave a brief presentation on the Big Society and the voluntary, community and faith sector.</p> <p>It was noted that the government has launched the £100 million transition fund to support charities, voluntary groups and social enterprises affected by public spending reductions www.biglotteryfund.org.uk/transitionfund</p> <p>Jonathan McWilliam gave a brief presentation on the key issues in the public health white paper. It was noted that there is likely to be one GP consortium in Oxfordshire and that this is expected to be functioning from 2013. Membership of Health and Well-being boards led by the upper tier local authority has yet to be defined. Oxfordshire has</p>	

		<p>pathfinder status for the new boards so will be involved in developing the emerging approach.</p> <p>In response to a question it was noted that management restructuring at the Radcliffe Hospital Trust is independent of these national changes.</p>	
5.	<p>Implications of the Comprehensive Spending Review</p>	<p>A number of public sector partners gave an overview of the implications of the spending review.</p> <p><i>Oxfordshire County Council</i> - Cllr Mitchell noted that it had revised its earlier savings target following the spending review but that it was anticipated that a considerable amount of the savings will need to be made in 2011/12. Proposals will be going into the public domain in coming weeks.</p> <p><i>Military</i> – Brigadier Baverstock gave an overview of the key implications of the defence review. Oxfordshire military bases have a positive outlook for the future.</p> <p><i>Police</i> – are facing home office cuts that are yet to be finalised but may not be as severe in Oxfordshire as other areas. Locally the policing structure is changing. In future there will not be an Oxfordshire level command unit. Delivery will be at the local area level with a number of functions being delivered on a force wide shared services model.</p> <p><i>Universities</i> – teaching budgets have been significantly cut already in anticipation of agreement to raise fees. Brookes are anticipating more of a consumer market and focus increasingly on the student experience and community.</p> <p><i>Business</i> – the feeling amongst businesses is more positive than the public sector and many expect to be hiring in 2011. However borrowing remains very difficult.</p> <p>There was discussion on the issues raised with the following points noted: Town and Parish councils are interested in increasing their role in delivering services locally - We are at a point of radical change in society and particularly what the public service delivery looks like in the future</p>	

6.	Local Enterprise Partnership	<p>Martin Tugwell gave a presentation on the new Local Enterprise Partnership. The presentation is available on the Oxfordshire partnership website: www.oxfordshirepartnership.org.uk .</p> <p>It was emphasised that the LEP will focus on growth.</p> <p>There was some discussion about the interface between the LEP and the OP which should focus on the wider economy.</p>
