Oxfordshire 2030 delivery plan: report on proposed approach to development and implementation	<p>The Partnership considered a paper (OP4) setting out a proposed approach to the development and implementation of Oxfordshire 2030 delivery plan.</p> <p>The proposed approach comprised:</p> <ul style="list-style-type: none"> - thematic partnerships and sub-groups to undertake detailed reviews of target performance; - the Public Service Board to be attended by Chairmen of the thematic partnerships, when required; - the Public Service Board to receive an annual summary of quarterly performance, together with exception reports on problem issues; - a thematic partnership report to be submitted on an annual basis to the Oxfordshire Partnership, highlighting progress made and bringing forward issues for strategic discussion; - a public, annual report on progress against priorities to be produced, with input from the thematic partnerships each year. <p>Claire Phillips confirmed that the LSP dimension would be integrated into the Plan via the 'Progress through Partnerships' project.</p> <p>The Partnership AGREED the above approach and a 2009/10 timetable for delivery as set down in the report OP4:</p>	Claire Phillips
