HONOUR BASED VIOLENCE RISK INDICATOR FORM

A FORCED MARRIAGE is an abuse of human rights-not a religious or cultural practice, a marriage conducted without valid consent of both parties where duress is a prime factor.

HONOUR BASED VIOLENCE-there is no typical case honour killings fall within the umbrella of honour crimes and honour based violence-many behaviours are linked.
